PRIVACY POLICY

1. Your privacy

We are committed to safeguarding the privacy of our clients. This policy sets out how we collect, use and disclose your personal information. As a private sector health service provider we adhere to the Australian Privacy Principles contained in the Privacy Act 1988 (Cth).

4. Disclosure of your personal information

We may disclose your personal information to the Australian Government Department of Health for the purposes of determining your eligibility for and administering the Hearing Services Program. 6. Security of your personal information
